Two orders of fertilizer to be spread by provider. The first order to be spread June 25th or 27th, 2024, beginning at 5:30am and 2nd order to be spread August 27th or 29th, 2024. Material shall be spread at 250 pounds per acre and spread charge shall be based on 88 acres per application. Each app shall be 11 tons of bulk and 1 ton in 50# bags for a total of 22 tons bulk and 2 tons in 50# bags. The fertilizer shall not be delivered more than 1 week prior to spread date.

The analysis shall be 20-2-20.

The nitrogen shall be derived from polymer coated urea only. The polymer coated urea shall be manufactured using the reactive layers coating process to insure longevity and controlled release. No substitutions will be accepted.

The potassium source shall be Muriate of Potash.
