SPECIFICATIONS FOR 72-INCH, OUT-FRONT, ROTARY MOWER

John Deere 1550, Toro 3200-D or equal
New – current year model

- Engine: 3-cylinder, 4-cycle, liquid cooled 24-horsepower diesel engine with 12-volt electric start
- Fuel capacity: 12 gallons minimum
- Controls: Hand operated throttle, PTO switch, hydraulic switch for lift /lower of implement, foot operated forward/reverse traction pedal
- Gauges: Fuel gauge, engine coolant temperature gauge and hour meter, indicator light for high engine coolant temperature, low engine oil pressure, ammeter, glow plugs
- Electrical: 12-volt automotive type electrical system, dash mounted ignition switch, 40-amp alternator. PTO, seat, and traction interlock safety switches
- Transaxle: Two-wheel drive, variable speed, axial position, hydrostatic in-line transmission; charge circuit hydraulics with 25 micron filtration provide hydraulic flow for power and implement lift
- Ground speed: 0 – 12 mph
- Implement lift: Two 2.5” hydraulic cylinders operate lift arms
- Steering: Steering valve controls single hydraulic steering cylinder, steering system is single tie rod type, tilt steering wheel with single lever control, 14-inch diameter steering wheel
- Tires/wheels: Two front traction drive tires: 23 x 10.5-12, turf tread, 4-ply rating
Two rear steering tires: 16 x 6.5-8, turf tread, 4 ply rating
- Brakes: parking brakes on front traction wheels, dynamic braking through traction drive
- Seat: Deluxe adjustable air ride seat
- Warranty: Two-year period

Mowing deck: 72-inch, rear discharge, 3-blade deck, mounted at the front of the mower (not "mid-mount" or "belly" mower)

Height of cut: 1 - 6 inches in 0.5-inch increments with spacers on the caster shafts

Construction of deck: 7 gauge steel, 5.5 inch deep, welded construction, flip up deck

Cutter drive: Isolation mounted PTO driven gearbox, 1.25" diameter spindle shafts, protected by rugged 9" conical spindle housing, turn on two greaseable tapered roller bearings (greaseable from top of deck), a positive splined connection attaches pulleys to spindle shafts

Caster Wheels: Two front and two rear caster wheels consisting of hard rubber or foam filled tires with roller bearings

Deck Covers: Quick-release covers

Additional equipment: Rear weight kit

Vendor to provide owner's manual, service manual, and parts manual in both digital and printed formats.

Vendor must have a full service center within 75 miles of the City of Mobile which has in stock commonly used parts and is capable of making any and all repairs to this unit.
