ORDINANCE TO ENFORCE A "STAY AT HOME ORDER" AND PUBLIC SAFETY CURFEW FOR THE CITY OF MOBILE DURING THE COVID-19 PUBLIC HEALTH EMERGENCY. The following ordinance was introduced by Councilmember Daves.

ORDINANCE: 39-011-2020

Sponsored by: Mayor Stimpson

AN ORDINANCE TO ENFORCE A "STAY AT HOME ORDER" AND PUBLIC SAFETY CURFEW FOR THE CITY OF MOBILE, ALABAMA DURING THE COVID-9 PUBLIC HEALTH EMERGENCY

WHEREAS, by Proclamation dated March 13, 2020, Governor Kay Ivey found that the appearance of COVID-19 in the State of Alabama creates the potential of widespread exposure to an infectious agent that poses a significant risk of substantial harm to a large number of people and declared a state public health emergency under ALA CODE Section 31-9-1, et seq; and

WHEREAS, by Resolution and Proclamation of Emergency dated March 17, 2020, the City Council of the City of Mobile, pursuant to its authority to provide for the health and safety of persons and property under ALA CODE Section 31-9-10(b)(1) and to preserve the health of the inhabitants of the municipality under ALA CODE Section 11-45-1, declared that it is in the best interest of the City to adopt policies and procedures consistent with directives from the Centers for Disease Control (CDC) to prepare and

protect the City from dangers arising from the unprecedented pandemic arising from the spread of COVID-19; and

WHEREAS, on April 3, 2020, the State Health Officer issued an Order Suspending Certain Public Gatherings Due to Risk of Infection by COVID-19, which directed every person in the State to stay at home unless engaging in an essential activity, including traveling to or working at an essential business or operation; and

WHEREAS, the City Council is authorized to adopt ordinances to preserve the health and welfare of the inhabitants of the municipality, Alabama Code Section 11-45-1; and

WHEREAS, the City Council is authorized to adopt by ordinance a public safety curfew for its inhabitants, to be enforced by its law enforcement agencies, Alabama Code Section 31-9- 10(b)(5)b; and

WHEREAS, the Council finds that COVID-19 presents a clear and present threat to the health, safety and welfare of the residents of the City of Mobile, and that it is in the best interests of the community to impose a public safety curfew to control community spread of COVID-19 in the City of Mobile and its police jurisdiction;

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Mobile, Alabama as follows:

SECTION 1: STAY AT HOME ORDER

The Order of the State Health Officer Suspending Certain Public Gatherings Due to Risk of Infection by COVID-19, as amended April 3, 2020, and applicable statewide, is hereby incorporated by reference as if set forth herein. A copy of said Order is attached hereto and labeled Exhibit 1. 2 43284711 v1

SECTION 2: PUBLIC SAFETY CURFEW

A. This Public Safety Curfew shall apply to all persons within the City of Mobile and its Police Jurisdiction. During the curfew, all persons shall remain in their places of residence and shall not be or remain in public places, except as further provided herein.

B. Subject to the exceptions in subsections C and D of this Section 2, all travel, including, without limitation, travel on foot, bicycle, scooter, motorcycle, automobile, or public transit is prohibited.

C. For the hours of 10 PM through 5 AM, the curfew shall not apply to:

1. Public safety workers, such as police, fire, and emergency service providers, including but not limited to law enforcement, fire and rescue, and dispatchers.

2. Public health workers, employees of hospitals, health care facilities, assisted living facilities, security companies, cemeteries, and mortuaries or related services.
3. Employees of utilities, cable, telecommunications, internet companies, wireless communication companies, and their contractors engaged in activities necessary to maintain or restore services.
4. Government employees or contractors necessary to maintain or restore infrastructure.
5. Employees of manufacturing facilities as defined in Section 2.d. of the attached Order.
6. Persons seeking emergency medical treatment.
7. Credentialed members of the media and necessary support staff.
8. Persons traveling through the city from one location outside the city to another location outside the city, returning to their city residences from outside the city, or traveling to their city residences from inside the city.
9. Persons experiencing homelessness.

D. From 5 AM to 10 PM, this Public Safety Curfew shall not apply to persons engaged in essential activities or traveling to or working at an essential business or operation, as set forth in the attached Order.

SECTION 3. PENALTIES AND FINES

A. It shall be unlawful for any person, firm or corporation within the corporate limits of the city or within the police jurisdiction thereof, to violate this ordinance. Any violation shall be subject to a fine of \$100 for the first offense, and \$200 for the second offense and each subsequent offense.

B. Mobile City Code Section 1-32, the Schedule of Fines, is amended to include the above fine.

SECTION 4. To the extent that this ordinance is in conflict with other ordinances of the City, this ordinance shall supersede the others until this ordinance is amended or repealed.

SECTION 5. If any subsection, sentence, clause, phrase, or word of this ordinance or any application of it to any person, structure, or circumstance is held to be invalid or unconstitutional by a decision of a court of competent jurisdiction, then such decision shall not affect the validity of the remaining portions or applications of this ordinance.

SECTION 6. This Ordinance shall be in full force and effect within the City of Mobile and its police jurisdiction, after its adoption and publication as otherwise required by law, and shall remain in effect for the duration of the State of Emergency as declared by Governor Kay Ivey on March 13, 2020.
